Mr. Schmidt reviewed the projected revenue for 22/23.

Motion by Jenner to approve the budget (\$2,913,345) for 22/23 as proposed. Second by Litsey, motion carried unanimously.

Motion by Jenner to approve the Certificate of Levy as proposed with no increase in taxes-\$664,900 general, \$15,000 building. Second by Schlepp, motion carried unanimously.

School meals will not be free this year--the DPI price equity tool indicates the district needs to raise meal prices by .10 for 22/23 to meet their requirements. Motion by Litsey to approve the meal prices as proposed. Second by Jenner, motion carried unanimously.

Motion by Litsey to approve the 21/22 district financial report as presented. Second by Schlepp, motion carried unanimously.

Motion by Litsey to approve the consolidated application for Title I, Title II, Title IV and REAP funds. Supt. Schmidt is the authorized representative and has the board's permission to submit this application. Second by Schlepp, motion carried unanimously.

Motion by Litsey to approve Mr. Schmidt as the authorized representative for the following: Title IX, ADA, Section 504, SE High Tech, Great Western Network, SCPSEU, CREA, AHERA & DOT Drug & Alcohol Safety. Second by Schlepp, motion carried unanimously.

Motion by Litsey to approve Mr. Doane as the authorized foster care liaison. Second by Schlepp, motion carried unanimously.

Outline of first/second/third offense consequences. Motion by Jenner to approve the handbook changes as presented. Second by Litsey, motion carried unanimously.
